### NOMINATION GUIDELINES

#### PURPOSE:

1. To recognize REALTOR® members of the Ada County Association of REALTORS® for effort and work expended in the interest of the association, fellow REALTORS®, their profession and the community.
2. To demonstrate to the general public the personal and professional accomplishments by REALTORS®.

#### NOMINATION AND SELECTION PROCESS:

1. Each broker in good standing may nominate one candidate for consideration as the ACAR REALTOR® of the Year.
2. The nominee must be an ACAR primary member for the year 2009, in good standing at the time of the nomination. Nominee must also remain a member in good standing to receive recognition at the time the ROTY award is presented at the 2010 Circle of Excellence Banquet.
3. Previous ROTY award recipients are not eligible for nomination.
4. The deadline for submitting nominations to ACAR is Wednesday, February 3<sup>rd</sup>, 2010. Late nominations will not be accepted.
5. The selection committee consists of recent ACAR ROTY's, with the immediate past ROTY serving as chair. The committee will select the REALTOR® of the Year and Distinguished Service Award recipients from the submitted nominations. Recipients will be announced at the Circle of Excellence Banquet on Friday, February 26, 2010.

Please attach description and/or documentation for each of the following categories:

**I. BUSINESS AND EDUCATIONAL ACCOMPLISHMENTS**

Business history of the candidate since entering the real estate business, including designations earned. Describe the candidates standing in the community as a REALTOR® and list specific contributions to the community through real estate. You may include business reputation with other REALTORS®, imaginative and creative marketing concepts, and clientele testimonials.

**II. LOCAL ACAR BOARD ACTIVITIES**

List in chronological order beginning with the most recent, limiting to the past 5 years only: Committee/task force participation, elected office positions, special assignments, special events, special achievements or recognition.

**III. STATE ASSOCIATION ACTIVITIES**

List in chronological order beginning with the most recent, limiting to the past 5 years only: Committee/task force participation, elected office positions, special assignments, special events, special achievements or recognition. Include attendance and participation at state meetings and conventions.

**IV. NATIONAL ASSOCIATION ACTIVITIES**

List in chronological order beginning with the most recent, limiting to the past 5 years only: Committee/task force participation, elected office positions, special assignments, special events, special achievements or recognition. Include attendance and participation at national meetings and conventions.

**V. COMMUNITY INVOLVEMENT**

Participation in and/or any offices held with local, state, and/or national civic and service organizations. List specific activities or accomplishments within each organization, limited to the past 5 years only.
