NOMINATION GUIDELINES

PURPOSE:

2. The nominee must be an ACAR primary member for the year 2011, in good standing at the time of the nomination. Nominee must also remain a member in good standing to receive recognition at the time the Rookie REALTOR® Award is presented at the 2012 Circle of Excellence Banquet.
3. Eligibility is limited to REALTORS® within their **first** licensing period only.
4. The deadline for submitting nominations to ACAR is Monday, February 6, 2012.
5. The awards committee will select the Rookie REALTOR® of the Year from submitted nominations. The Rookie REALTOR® of the Year recipient will be announced at the Circle of Excellence Banquet on Saturday, March 10, 2012.
